Date: August 11, 2020

I have attached a revised Reopening Plan for the 2020-2021 academic year per School Committee recommendations from the August 7th, 2020 Special School Committee Meeting. I have included those recommendations below as well as the page numbers those changes can be found in the plan. You will find those changes in red text. Additionally, I have noted any changes we made that were not recommendations, but instead were a result of our continued planning.

Finally, the building principals decided to change the format of their plans based on recommendations from School Committee for greater consistency among school plans. Instead of individual school plans, you will find all five schools listed at the top of the page with common subsections listed to the left of the page. AES and CES submitted one plan representing both elementary plans—they separated out the schools only where the information was pertinent to each school. There are three plans representing each of the learning models: remote, hybrid and in-person.
