Next Generation MCAS

As a leadership team, we continue to attend webinars and participate in conversations with the Massachusetts Department of elementary and Secondary Education (DESE) regarding the implementation of the next generation assessment, which has been dubbed MCAS 2.0. As indicated in a previous week in review, this assessment will be controlled by Massachusetts and the intention is to incorporate aspects of MCAS and PARCC. IT is still not clear how much of the test will be 'PARCC-like' and how much will resemble what our students have been exposed to with MCAS testing. This test will not be administered until the spring of 2017. In the meantime, the district will need to make a decision regarding test administration for the spring 2016. We have the option to continue with MCAS for one more year or to administer the PARCC assessment this year. There are certain advantages and disadvantages to each approach. My initial inclination is to remain with the MCAS, which will incorporate a sampling of PARCC questions. However, I want to take some time to explore both options more fully with our administrative leadership team and with the school committee before making a final recommendation to the school committee. Our administrative team will meet on December 10 to discuss the options. I will present the outcome of our discussions and my final recommendation to the school committee at the regular meeting on December 21. Any feedback or input is greatly appreciated as we explore the testing for this spring.
