Highlights from Monday's School Committee Meeting...

AFT Paraprofessionals, AFT Multi-Purpose Facility Technicians, and AFSCME Cafeteria Workers—Contract Ratifications: The personnel subcommittee of the school committee recently reached a tentative agreement on successor contracts for paraprofessionals, multipurpose facility technicians, and cafeteria workers lasting from September 1, 2016 – August 31, 2019. The vote to ratify the contracts was unanimous by the school committee, with Gretchen Marinopoulos and Nick Wheeler not present for the vote. In addition to some revised contract language, the salary increases include:

Paraprofessionals/Multi-Purpose Facility Technicians

FY 17: 1%

FY 18: 1% on day one

1% on day 91

FY 19: creation of a new super step at 2.5% above the top step

1% on day one 1% on day 91

Cafeteria Workers:

FY 17: 2% FY 18: 2% FY 19: 2%

Policy Approval

BEDB-E: Agenda Format – Last Fall, the agenda format was adjusted slightly. The Presentations and Reports section were combined. There is a school committee policy which identifies the structure of the meetings. Additionally, it was felt that the press conference item should be removed, as there is very rarely a need for the press conference. This was the second reading for the policy and the changes were approved unanimously.

JJE – Student Activity Accounts – Director of Finance and Operations Joan Liporto reviewed the current student activities policy, along with reviewing the recommendations from the MASBO report. Ms. Liporto developed an updated policy that reflects changes as recommended in the MASBO report and constitutes best practice for maintaining student activity accounts. These changes were voted on and approved unanimously. BEC – Executive Session – The executive session policy, as written, called for a quarterly review of executive session minutes. A proposal was made by the policy subcommittee to alter the timeline to an annual review. Because of the minimal nature of the change, there was a vote to waive the first reading of the policy and to take an immediate vote for approval. Both the vote for the immediate review and the vote for the change were approved unanimously.


Review of School Committee Goals – Public Relations Goal #1: The school committee is continuing to review the goals that were established earlier in the year to ensure progress. During this meeting, the committee discussed public relations goal #1. This goal states:

The Amesbury School Committee will continue to strengthen its relationship with the Amesbury City Council. Through cooperative dialogue, both parties can be better informed and prepared to find solutions to our funding challenges.

a. Ongoing. Continue to participate in the Joint Education Subcommittee with representatives from the Amesbury City Council. This group will meet at least quarterly to discuss local educational issues raised and to pave the way for successful annual and long term budget development.

It was discussed that the committee is meeting this goal, as there are regularly scheduled meeting of the Joint Education Committee (City Council and School Committee representation). The next meeting will be held on November 30, 2016.

Presentation by Cashman School: The Cashman School Council attended the school committee meeting to highlight the various activities coordinated throughout the year by the student council. Their presentation was impressive, as each student took a turn at the podium to highlight one of the activities. While visiting the schools on Tuesday, I had an opportunity to see first-hand, one of the student council's events – the annual food drive. I am proud of our student council and of all the students for their commitment to helping those



Presentation by Ms. Jacques, Director of Teaching and Learning

Ms. Lyn Jacques, Director of Teaching and Learning, along with a team of staff from the Amesbury Public Schools, were present to describe the multi-year curriculum effort. Ms. Jacques described briefly the context of why there is a need for a curriculum review, which included MCAS data, along with information about changes in curriculum frameworks and standards. Ms. Jacques explained the lens through which the curriculum work was being driven. This process is called Understanding by Design. The district has contracted with a consultant from the developer of this curriculum review approach. In addition, Ms. Jacques, along with Ms. Eryn Maguire (principal of the Amesbury Innovation High School) defined social emotional learning and its importance to meeting the needs of all students. At the conclusion of the presentation, it was shared how innovative the work is in Amesbury – the team was invited to present at the National Association for Curriculum Development (ASCD) Conference, as well as the annual DESE Title I Conference. There is a lot of interest from people outside of Amesbury about how we are infusing social emotional learning directly into curriculum development across all content areas. During this event, grade-levels compete in various challenges and also have to present a skit in order to determine the winning class for school spirit. It is always a fun event, where students and staff alike show their enthusiasm for our school.
