- I. Call to Order/Mission Statement/Pledge of Allegiance (1:45) Mayor Gove called the meeting to order. Ms. Smith read the mission statement and led the committee in the Pledge of Allegiance.
- II. Comments by Visitors & Delegations (3:30)
 - Karen Brannely 12 Old Tavern Ln Ms. Brannely, an APS Teacher, spoke about the need for additional SPED staff.
 - Christine Manclark 80 Friend St Ms. Manclark spoke to the committee about the importance of music and arts in the schools.
 - Kebbie Knowland 5 Unicorn Cir Ms. Knowland asked why DEI was a priority in schools.
 She does not believe it should be.
 - Dan Fijalkowski 5 W Whitehall Rd Mr. Fijalkowski, an APS music teacher, shared that a
 lot of 8th grades were looking at Whittier and noted a thriving music program may keep
 them in district.
