September 6, 2016

Present at 7:00 p.m. were Mayor Gray, Chair; Deb LaValley, Tom McGee, Peter Hoyt, Rob Chamberlain, Gretchen Marinopoulos, and Nicholas Wheeler. Absent were: Dr. Gary Reese, Superintendent of Schools and Sydney Knowlton, SAC Representative.

#### Ĭ. CALL TO ORDER

Mayor Gray called the meeting to order at 7:02 PM and Nick Wheeler led the committee in the Pledge of Allegiance and read the Mission Statement.

#### Π. COMMENTS BY VISITORS, DELGATIONS

Cindy Yetman, AFT President, addressed the committee regarding Question 2 on ballot, Charter Schools. She urged the public to vote "NO" on Question 2, stating that a yes vote would hurt public school funding.

Walter Armstrong, also addressed the members, explaining that if this Resolution passes, public schools will lose Chapter 70 funding. He went on to explain that Charter Schools are private entities, not public schools. Mr. Armstrong presented the committee with an updated "Resolution Against Lifting The Cap On Commonwealth Charter Schools" and read aloud.

Ms. LaValley stated that on June 20th, this committee voted on that Resolution, but noted that this one has different dollar amounts. Mr. Hoyt stated that this one has more updates and should be revoted on to join the partnership with the AFT Union.

A copy of the signed Resolution will be attached to these minutes.

Motion by Mr. Hoyt, seconded by Mr. McGee to reaffirm the commitment with the "Resolution Against Lifting The Cap On Commonwealth Charter Schools" with the updated amounts. Vote: Yes, Unanimous.

# Resolution Against Lifting the Cap on Commonwealth Charter Schools

WHEREAS, free public schools available to all students regardless of income, ability, need or English language proficiency are foundational to our democracy; and

WHEREAS, all of our students deserve high-quality public schools that teach the whole child, providing enrichment and addressing social and emotional needs in addition to core academic subjects; and

WHEREAS, local accountability for our public schools is necessary to ensure that schools are responsive to the needs of their communities; and

WHEREAS, Amesbury is losing \$490,558 to Commonwealth charter schools and public school districts across the state are losing more than \$408 million this year alone — a loss of funds that is undermining the ability of districts to provide all students with the educational services to which they are entitled; and

WHEREAS, Commonwealth charter schools are often approved over the objections of a majority of community residents and their elected officials and are not accountable to local elected officials once they are approved; and

WHEREAS, Commonwealth charter schools often fail to serve the same proportion of special needs students, low-income students and English language learners as the districts from which they receive students and often use high suspension rates to drive out students they don't want to serve; and

WHEREAS, the Commonwealth charter school system is creating separate and unequal opportunities for success; and

WHEREAS, lifting the cap on charter schools would greatly worsen the problems listed above and lead to a costly and divisive two-track school system;

**THEREFORE**, be it resolved that the Amesbury School Committee in concert with AFT Amesbury, LOCAL 1033 opposes lifting the cap on Commonwealth charter schools.
